
Office Order

2. Terms & Conditions:

- He will not be allowed to stay abroad beyond the approved period;
- He will inform the government as soon as he returns to the country;
- His wife Zeb Un Nessa Chowdhury will accompany him; and
- All the expenses in connection with the visit shall be borne by Dr. Salim Akhter Chowdhury himself.

3. This order is issued with the approval of the competent authority.


